I am particularly interested in this opportunity because I have a passion for public service and aspire to work in the field of energy regulation.

My legal education and professional experience have given me strong research and writing skills that will help me succeed as a clerk. For example, as a Research Assistant to Donna Attanasio, the Senior Advisor for Energy Law Programs at The George Washington University Law School, I have conducted extensive research on jurisdictional, regulatory, and financial obstacles to the implementation of smart grid technologies. Additionally, as a Senior Notes Editor for the *George Washington Journal of Energy and Environmental Law*, I help students write and edit their scholarly notes. Last year I drafted a scholarly note which examined the Foreign Investment and National Security Act of 2007 and its potential effects on renewable energy investment in the United States. As an intern with the Environmental Protection Agency ("EPA"), I wrote a research paper analyzing Dominion Virginia Electric and Power Company's proposed Renewable Generation Pilot Program, which strengthened my understanding of utility regulation and green energy programs.
